Cohort 2 Details

ELIGIBILITY CRITERIA:

• Active Students, Faculty, and Staff of public and private sector universities.

LICENSE DISTRIBUTION:

- The total number of available licenses is **30,000**.
- Cohort 1 learners are not eligible to apply for Cohort 2.
- DLSEI 2.0 learners can apply.
- The application portal will remain open for 'X' days, and a collective Coursera invite will be sent to approved applicants on June 21, 2025.

COURSERA CATALOG:

• Total Enterprise Catalog: 13,000+

VERIFICATION PROCESS OF FOCAL PERSONS:

- **STEP 01:** A University will nominate a Focal Person.
- **STEP 02:** An account will be created on the **eservices portal** at eservices.hec.gov.pk.
- **STEP 03:** Focal Person is required to share his/her account details with HEC's DLSEI team.

STEP 04: Admin dashboard access of the eservices portal will be given to FP.

STEP 05: FP can view dashboard at eservices portal after **"Login"** and can **"view, approve or reject"** applications.

HOW TO APPLY?

STEP 01: Register or Sign in at the portal: https://eservices.hec.gov.pk.

- **STEP 02:** Click at **eCourses** in the left Menu bar.
- **STEP 03:** Fill the **"Registration"** form with correct details.
- **STEP 04:** Submit your application. After submission, application with "**Submitted**" status will be listed at your Dashboard.
- **STEP 05:** The application can be approved or rejected by FP using the admin dashboard. Admin dashboard for applicant verification will be available for "X" days.

REVOCATION POLICY:

Policy 1:

Learners must accept the Coursera license invitation and enroll in at least one course within 15 days of receiving it. Failure to do so will result in license revocation.

Policy 2:

Learners must complete at least one individual course within 30 days of receiving the license invitation to retain access.

Failure to comply with either of the above policies may result in the cancellation of the license.

Revamped eservices Admin Portal Details

- 1. Focal persons can approve multiple applicants simultaneously.
- 2. Comments section for approved applicants removed.
- 3. Evidence doc will not be downloaded.
- 4. Submitted applicants will appear at the top of the list to avoid the need for searching.
- 5. The session will retain the current page after an action is taken. For example, if a focal person is working on page 2 and verifies an application, the site will remain on page 2, not return to page 1.
- 6. Additionally, when a filter is applied via search, the session will retain the applied filter even after verifying an applicant.
- 7. Portal speed optimized.

LEARNER'S APPLICATION VERIFICATION PROCESS:

- **STEP 01:** The DLSEI/e-Course application will **undergo a review process** and approval by the assigned Focal Persons within the respective universities.
- **STEP 02:** On 21st June, all approved applicants will receive an email from Coursera with instructions to join the Coursera portal.

DLSEI 3.0 LAUNCH:

- The registration portal will become accessible subsequent to an official announcement by HEC.
- A marketing kit will be distributed to facilitate the dissemination of information.
- Print materials will be sent to universities for notice boards.
- Online webinars will be organized to deliver training and guidance sessions.
- All announcements and updates will be promptly shared through various social media platforms and groups.
